Minutes of the Special Council Meeting held Tuesday 21 August 2007, commencing at 5.08 pm in the District Council of Robe Chambers, Smillie Street, Robe.

BUSINESS **Adoption of the Annual Business Plan 2007/08**

Cr Riseley moved **that:-**

- 1. Council acknowledge the level of interest from the community with respect to elements of the Annual Business Plan; and**
- 2. Thank individuals and groups in the community whom provided submissions; and**
- 3. Having considered the public submissions, adopt the 2007/08 Annual Business Plan (75/2008)**

Adoption of the 2007/08 Budget

Cr Mathews moved **that Council adopt the draft budget as the District Council of Robe's Budget for the 2007/08 fiscal year. (76/2008)**

Adoption of Capital Valuation, Declaration of General Rate and Service Charges for the Year ending 30th June 2008

Cr Petrovic moved **that:-**

- 1. That pursuant to Sections 168, 169 and 170 of the Local Government Act 1999 the most recent valuation of the Valuer General as at 21st August 2007 within the Council's area of \$736,303,740 be adopted for the 2007-2008 financial year; and**
- 2. That pursuant to Section 153 of the Local Government Act 1999 for the fiscal year ending 30th June 2008 a single General Rate of 0.003188 cents in the dollar be declared**

for rateable land for all categories of land use in the Council area; and

- 3. That pursuant to Section 158(1)(a) of the Local Government Act 1999 for the fiscal year ending 30th June 2008 that a minimum amount payable by a way of rates of \$515 be fixed in respect of rateable land in the Council’s area; and**
- 4. That pursuant to Section 155 of the Local Government Act, 1999 for the fiscal year ending 30th June 2008 that an annual Waste Management unit charge of \$234.50 for the prescribed service of waste management by imposed on each separate assessment, with the exception of vacant land; and**
- 5. That pursuant to Section 181(2)(a) of the Local Government Act 1999, for the fiscal year ending 30th June 2008 rates and services charges will be payable in four instalments. The instalments will be payable in the months of September, December, March and June of the financial year for which the rates are declared; and**
- 6. That a separate rate of \$33.80 per property be imposed for collection on behalf of the South East Natural Resources Management Board area for the year ending 30 June 2008; and**
- 7. That separate rates for the provision of STEDS services be provided as follows:**

Occupied with desludging	\$287.50
Occupied without desludging	\$252.50
Unoccupied	\$190.00 (77/2008)
