6.1.1 Road Opening and Closing – Old Naracoorte Road

Cr Wright moved **that the following Order to Open and to Close Road be made subject to suitable access being provided to Section 141, Hundred of Ross, in favour of Royden Pty Ltd, via the drainage reserve:**

1. ORDER TO OPEN ROAD

The following land is **OPENED AS A ROAD**:
Portion of Section 119, Hundred of Ross forming a re-alignment of the Old Naracoorte Road as delineated and numbered '1' in Preliminary Plan No. 10/0003.

This land is the whole of the land specified in the public notice of this road opening given in the Coastal Leader newspaper of 3 February 2010 and the Government Gazette of 4 February 2010.

2. LAND TO BE EXCHANGED FOR CLOSE ROAD

The land described in order 1 is to be exchanged in accordance with the agreement for exchange referred to in order 4(i) for that part of the road closed by this order that is defined in order 3(i).

3. ORDER TO CLOSE ROAD

The following road is hereby **CLOSED**:
Those portions of the public road (Old Naracoorte Road) rendered superfluous by the road opening described in order 1 of this order,

- (i) being that portion of the road dividing Section 141 from Section 119 in the Hundred of Ross more particularly delineated and lettered 'A' in Preliminary Plan No. 10/0003.
- (ii) being that triangularly shaped portion of the road dividing Section 101 from Section 137 in the Hundred of Ross more particularly delineated and lettered 'B' in Preliminary Plan No. 10/0003.

4. ORDER TO CLOSE ROAD

The road closed by this order must be dealt with in accordance with the following order:

- (i) Transfer the whole of the land subject to closure marked 'A' to Richard George OGILVIE in accordance with Agreement for Exchange dated 10 February 2010 entered into between the District Council of Robe and RG Ogilvie.
- (ii) Add the whole of the land subject to closure marked 'B' to Section 137, Hundred of Ross, which land is dedicated under the Crown

**Lands Act 1929 as amended for drainage
purposes. (251/2010)**
