General Information

Casual Mooring—Casual mooring is available within the Marina. Information on prices availability and forms that need to be completed can be accessed via Council's Website, www.council.robe.sa.gov.au or by contacting Council on 08 8768 2003.

Fuel—Fuel (diesel only) bowsers can be accessed 24 hours a day, by using a credit/debit card with a pin code attached

Power & Water—is available to all berths.

Depth of channel—is 2m at low tide.



Lake Butler Marina Rules & Regulations



Marina Rules and Regulations

- 1. Tenants shall not throw, deposit, discharge, pump or otherwise place any refuse, rubbish, debris, oil, spirits, paint, swage, flammable material or any other pollutants of any description upon the pontoons or water of the marina. Any governmental fines, including the cost of cleanup, resulting from the actions of the Tenant shall be the sole responsibility of the Tenant. Oil is to be deposited in the waste oil station located in the hardstand area or Council transfer station. Waste oil is not be placed in or besides the garbage bins, or spilled in the marina. Docks shall be kept clean from grease, oil spray paints or any other staining material. Tenant shall be responsible for all cleanup costs.
- 2. Tenants vessels, while inside the Marina or in the channel leading to the Marina beginning at the breakwater shall create no wake. Maximum speed in the Marina and channel is four (4) knots or no wake, which ever occurs first.
- 3. There shall be no barbecues, welding equipment, burning torches or any other open flame apparatus used within the marina, unless authorized by Council. Gas barbecues securely mounted within the boat are acceptable.
 - 4. There will be no refueling from portable containers within the marina.
- 5. No part of any vessel may extend over the main walkways. All boats shall be moored in a safe and secure manner on cleats with strong mooring lines. In the event the Council deems the Tenant's mooring lines to be unsafe, the Council may replace said lines and the Tenant shall pay all costs.

- 6. There is no construction of any kind allowed on or to the pontoons. The Council reserves the right to remove, add or adapt any existing construction, addition, or modification made to any portion of the pontoons, not limited to, but including dock boxes and stair's.
- 7. Water, electrical cords or mooring lines shall not be placed across walkways. All electrical cords must be marina grade, have a plug that is water tight and be tagged and tested. No gear of any kind shall be stored on the pontoons.
- 8. Dinghies, kayaks or tenders are to be stored in the water within the Tenant's berth or on the Tenant's vessel, unless otherwise approved by Council.
- If any vessel sinks within the marina, Tenant must immediately take action to remove the vessel. If the Tenant fails to take immediate action, Council will do so and Tenant shall pay all costs incurred in such removal.
- 10. Pets shall be leashed at all times when on the Marina premises. Pet owners must clean up after their animals and dispose of excrement in a proper container.
- 11. Auxiliary motors on sailing vessels must be used within the Marina, sailing within the Marina is prohibited. Sailing vessels without auxiliary power must arrange for towing within the Marina.
- 12. Marina rubbish bins are for vessel rubbish only and not for household use. Cardboard must be broken down and placed in the bins or taken to the Council transfer station.
- 13. Extended usage or "live aboard" situations must be approved by Council. No substance or material whatsoever, including human waste, may be discharged into the water. Waste may only be discharged in a approved sewage disposal facility.

- 14. All pontoons and finger pontoons must be kept clear at all times to permit easy access by emergency crews and their equipment. The Council reserves the right to confiscate any items left on the pontoons and pontoon fingers at any time and dispose of these items immediately at the cost of the tenant. Storage of any confiscated items will also be at the cost of the tenant.
- 15. The Marina Rules and Regulations summarized herein and as amended from time to time and all other policies and regulations established by governmental agencies or the Council shall form a part of the Marina Rental Agreement as if set forth fully therein.
